<p>Answer:</p> <p>The below activities may result in a different level of net operating cash flows going forward to that achieved in the Quarter. The Company successfully completed a rights issue in June 2020 (Refer ASX announcement 3 June 2020) which raised A\$5.2m (before costs). The proceeds will be used to advance the search for the primary kimberlite sources of the high-value Lulo alluvial diamonds, preserve mining assets suspended as a result of the COVID-19 pandemic and for general working capital purposes. The impact of the COVID-19 pandemic is being actively reviewed and the Company expects to return Mothae to full operation status as soon as the pandemic and market constraints allow.</p>
