#### **SECTION 708A NOTICE**

Lucapa Diamond Company Limited (ASX: **LOM**) ("Lucapa" or "the Company") has today completed the issue of 157,008,769 fully paid ordinary shares (**Placement Shares**) to sophisticated and professional investors, at an issue price of \$0.055 per Placement Share, as part of the placement to raise approximately \$10 million (before costs), as previously announced on 6 November 2020.

Further, the Company has issued 4,345,415 fully paid ordinary shares (**Restructure Fee Shares**) and 869,083 listed \$0.10 options (**Restructure Fee Options**), expiring 5 June 2022 to New Azilian Pty Ltd (or its nominee) in part satisfaction of the Restructure Fee following shareholder approval at the general meeting held on 12 November 2020.

As required under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that;

- (a) The Placement Shares, Restructure Fee Shares and Restructure Fee Options were issued without disclosure under Part 6D.2 of the Corporations Act.
- (b) This notice is being given under paragraph 5(e) of section 708A of the Corporations Act.
- (c) As at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act (as they apply to the Company) and section 674 of the Corporations Act.
- (d) As at the date of this notice, there is no excluded information with respect to the Company for the purposes of sections 708A(7) and (8) of the Corporations Act.
