Answer:

No. Operating cash flows in Q4 2020 were impacted by the decision to defer Mothae diamond sales from December 2020 to January 2021. Post Quarter end, as per ASX announcement dated 11 January 2021, Mothae reported the sale of 4,676 carats for US\$5.6 million.

The Company is further expecting improved operating cash flows due to recovering diamond market conditions and the completion of the expansion to the processing capacity at Mothae.

As per the ASX announcement dated 13 January 2021, operations at Mothae were temporarily suspended following the Lesotho Government's imposition of a 14 day nationwide lockdown. Operations are expected to resume at the conclusion of the lockdown.
