Lucapa Diamond Company Limited (ASX: **LOM**) ("Lucapa" or "the Company") has completed the issue of 195,254,788 fully paid ordinary shares (**Tranche 1 Placement Shares**) at an issue price of \$0.05 per Placement Share as part of the placement to raise approximately \$20 million (before costs), as previously announced on 24 May 2021.

As required under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that;

- (a) The Tranche 1 Placement Shares were issued without disclosure under Part 6D.2 of the Corporations Act.
