SECTION 708A NOTICE

Lucapa Diamond Company Limited (ASX: **LOM**) ("Lucapa" or "the Company") has completed the issue of 204,745,212 fully paid ordinary shares (**Tranche 2 Placement Shares**) at an issue price of \$0.05 per Placement share and 5,000,000 Advisor Options (unlisted \$0.08 options, expiring 30 July 2025), as part of the placement to raise approximately \$20 million (before costs), as announced on 24 May 2021, following shareholder approval at the general meeting held 13 July 2021.

The Company also wishes to advise that it has issued 432,303 fully paid ordinary shares (**Shares**) in relation to retention incentives held by senior mine management. This follows the exercise of the third tranche of vested performance rights expiring 1 April 2022 (Refer ASX announcement 4 April 2019) (**Performance Rights**).

As required under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that;

- (a) The Tranche 2 Placement Shares and Shares were issued without disclosure under Part 6D.2 of the Corporations Act.
- (b) This notice is being given under paragraph 5(e) of section 708A of the Corporations Act.
- (c) As at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act (as they apply to the Company) and section 674 of the Corporations Act.
- (d) As at the date of this notice, there is no excluded information with respect to the Company for the purposes of sections 708A(7) and (8) of the Corporations Act.
