#### **SECTION 708A NOTICE**

Lucapa Diamond Company Limited (ASX: **LOM**) ("Lucapa" or "the Company") has allotted 125,000 fully paid ordinary shares (Shares) following the exercise of 125,000 vested Performance Rights pursuant to the Company's Incentive and Retention Plan, as approved by shareholders on 26 May 2016.
