



SECTION 708A NOTICE – BROOKING DIAMOND PROJECT

Lucapa Diamond Company Limited (**ASX: LOM**) (“Lucapa” or “the Company”) has allotted 250,000 fully paid ordinary shares (“Shares”) and 500,000 \$0.53 unlisted options, expiring 15 May 2019, to Leopold Diamond Company Pty Ltd (“Leopold”) for an 80% interest in the Brooking Diamond Project tenements in Western Australia held by Leopold, as announced on 13 October 2016.
