## **DIAMOND SALE UPDATE**

Lucapa Diamond Company Limited (ASX: **LOM**) ("Lucapa" or "the Company") and its partners, Empresa Nacional de Diamantes E.P. ("Endiama") and Rosas & Petalas, have completed the fifth sale for 2017 of alluvial diamonds from the Lulo Diamond Project in Angola.

The sale of 1,236 carats of Lulo diamonds achieved gross proceeds of US\$0.95 million (A\$1.25 million), representing an average price per carat of US\$770 (A\$1,013) per carat.

The sale brought gross proceeds from Lulo diamond sales to date in 2017 to US\$15.4 million (A\$20.3 million) at an average price per carat of US\$1,620 (A\$2,132).

As with the previous sale, the diamonds from the latest sale parcel were sourced primarily from Mining Block 28.

Mining has since returned to higher-value Mining Blocks 8 and 6 following the end of the Angolan wet season.
