## SECTION 708A NOTICE

Lucapa Diamond Company Limited (ASX: **LOM**) (“Lucapa” or “the Company”) has allotted 9,401,166 fully paid ordinary shares (Shares) following the exercise of 9,401,166 \$0.20 listed 30 September 2017 options (LOMOA).

Pursuant to the underwriting agreement the Company has also allotted 4,224,697 fully paid ordinary shares (Underwriting Shares) and 11,600,000 unlisted \$0.35 options, expiring 30 September 2018 (Fee Options) to the underwriter, Westar Capital Limited.

The issue of these securities completes the underwritten A\$9.2m conversion of the LOMOA options, as announced to the ASX on 3 October 2017.
