SECTION 708A NOTICE

Lucapa Diamond Company Limited (**ASX: LOM**) ("Lucapa" or "the Company") has allotted 3,223,350 fully paid ordinary shares ("Conversion Shares") pursuant to Conversion Notices to Equigold Pte Ltd ("Equigold") in respect of the quarterly interest and fees due in accordance with the terms of the US\$15 million Equigold loan facility (Refer ASX announcement 9 October 2017). The outstanding balance has been reduced to US\$7.5 million.

As required under section 708A(6) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that;

- (a) The Conversion Shares were issued without disclosure under Part 6D.2 of the Corporations Act.
- (b) This notice is being given under paragraph 5(e) of section 708A of the Corporations Act.
- (c) As at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Corporations Act (as they apply to the Company) and section 674 of the Corporations Act.
