#### **SECTION 708A NOTICE**

Lucapa Diamond Company Limited (ASX: **LOM**) ("Lucapa" or "the Company") has issued 490,267 fully paid ordinary shares (**Shares**) in relation to retention incentives held by staff at the Company's Lulo and Mothae operations. This follows the exercise by the operations staff of the second tranche of vested performance rights expiring 1 April 2022 (Refer ASX announcement 4 April 2019)(**Performance Rights**).

The Company also advises that 269,146 Performance Rights have been cancelled and 2,500,000 \$0.35 unlisted options exerciseable on or before 20 April 2020 have expired without exercise.

As required under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that;

- (a) The Shares were issued without disclosure under Part 6D.2 of the Corporations Act.
- (b) This notice is being given under paragraph 5(e) of section 708A of the Corporations Act.
