



SECTION 708A NOTICE

Lucapa Diamond Company Limited (**ASX: LOM**) (“Lucapa” or “the Company”) has allotted 3,252,835 fully paid ordinary shares (“Conversion Shares”) pursuant to Conversion Notices to Equigold Pte Ltd (“Equigold”) in respect of the quarterly interest and fees due in accordance with the terms of the US\$15 million Equigold loan facility (Refer ASX announcement 9 October 2017). The outstanding principal has been reduced from US\$15 million to US\$5.9 million.

As required under section 708A(6) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that;

- (a) The Conversion Shares were issued without disclosure under Part 6D.2 of the Corporations Act.
